### **Online Main Examination for recruitment of PO/MTs in Participating Organizations**

#### **GUIDELINES REGARDING PERSONS WITH DISABILITIES** **USING THE SERVICES OF A SCRIBE**

The facility of Scribe / Reader would be allowed to Visually Impaired (VI), Orthopedically Challenged (OC) and candidates suffering from autism, intellectual disability, specific learning disability and mental illness who have disability of 40 % or more if so desired by the person. The facility of scribe is meant for only those candidates with disabilities who have physical limitation to write including that of speed. In all such cases where a scribe is used, the following rules will apply:

- Please ensure that you are eligible to use the services of scribe as per Govt. of India guidelines governing the recruitment of Persons with Disabilities.
- The candidate will have to arrange his/ her own scribe at his/ her own cost.
- The scribe can be from any academic discipline.
- The qualification of the Scribe should be one step below the qualification of the candidate taking examination.
- Both, the candidate as well as the scribe will have to give a suitable undertaking, in the prescribed format with passport size photograph of the scribe, conforming that the scribe fulfils all the stipulated eligibility criteria for a scribe as mentioned above. Further, in case it later transpires that the candidate/scribe did not fulfill any of the laid down eligibility criteria or has suppressed any material facts, the candidature of the applicant will stand cancelled, irrespective of the result of the test/ examination.
- Candidates with disability who have physical limitation to write including that of speed shall be allowed compensatory time of 20 minutes per hour of the examination whether availing the facility of scribe or not.
- Any candidate who is not eligible to use scribe as per the guidelines referred to above, but uses scribe in the examination shall be disqualified to participate further in the recruitment process. Any candidate who is using scribe should ensure that he/she is eligible to use scribe in the examination as per the above guidelines. Any candidate using scribe in violation of the above guidelines shall stand disqualified and can be removed from service without notice, if has already joined the Bank.

#### **DECLARATION**

We, the undersigned, Shri/Smt./Kum. \_\_\_\_\_ **eligible candidate having qualification** \_\_\_\_\_ for the Online Main Examination for POs/ MTs in Participating Organizations to be held on **18.11.2018** and Shri/Smt./Kum. \_\_\_\_\_ **eligible writer (scribe) having qualification** \_\_\_\_\_ for the eligible candidate, do hereby declare that: -

1. The scribe is identified by the candidate at his/her cost and as per own choice.
2. The candidate is Visually Impaired or Orthopedically Challenged or autistic or intellectual disable or suffering from specific learning disability or suffering from mental illness who has physical limitation to write including that of speed and he/she needs a writer (scribe) as permissible under the Government of India rules governing the recruitment of Persons with Disability.
3. The qualification of the Scribe is one step below the qualification of the candidate taking examination.
4. In case it is found that the qualification of the scribe is not as declared by the candidate and is beyond the qualification of the candidate, the candidate shall forfeit his/ her right to the post and claims relating thereto.

5. Visually Impaired or Orthopedically Challenged or Autistic or Intellectual disable or suffering from specific learning disability or suffering from mental illness candidates who have physical limitation to write including that of speed shall be allowed compensatory time of 20 minutes per hour of the examination whether availing the facility of scribe or not.
6. In view of the importance of the time element, the examination being of a competitive nature, the candidate undertakes to fully satisfy the Medical Officer of the Bank that there was necessity for use of a scribe as he/she has physical limitation to write including that of speed by the disabilities as mentioned in Paragraph 1.
7. The candidate has ensured that the scribe is not a candidate for this process (CRP-PO/MT- VIII).
8. The scribe has ensured that he/she is not appearing as a candidate in this process (CRP-PO/MT- VIII).
9. We hereby declare that all the above statements made by us are true and correct to the best of our knowledge and belief. We also understand that in case it is detected at any stage of recruitment that we do not fulfill the eligibility norms and/or that the information furnished by us is incorrect/false or that we have suppressed any material fact(s), the candidature of the applicant (both the candidate as well as scribe in case he/she has appeared in the same examination) will stand cancelled, irrespective of the result of the written test(s). If any of these shortcomings is/are detected even after the candidate's appointment, his/her services are liable to be terminated. In such circumstances, both signatories will be liable to criminal prosecution.
